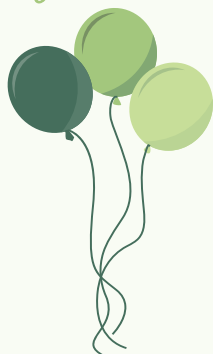

### HYACINTHS ZUCCHINI SLICE

#### INGREDIENTS:

- 350G ZUCCHINI
- 1 CARROT
- 1 ONION
- 5 EGGS
- 1 CUP CHEESE
- 1 CUP SELF-RAISING FLOUR
- 1/4 CUP OIL
- 1 TABLESPOON CHICKEN STOCK
- 1 STRIP OF BACON
- SPRINKLE OF PAPRIKA (OPTIONAL)



#### METHOD

1. GRATE UNPEELED ZUCCHINI & CARROT
2. CHOP ONION & BACON FINELY
3. FRY CHOPPED ONION & BACON
4. IN MIXING BOWL ADD ALL INGREDIENTS (EXCEPT PAPRIKA) & MIX WELL
5. LINE TIN WITH NON STICK BAKING PAPER
6. FILL TIN WITH MIXTURE BUT NOT TOO HIGH
7. SPRINKLE SLICE WITH PAPRIKA
8. BAKE AT 180 FOR APPROX. 40-45 MINUTES
9. LET SLICE COOL SLIGHTLY BEFORE CUTTING/SERVING

## COVID-19 BOOSTER VACCINATION PROGRAM

The Federal Government recently announced that a COVID-19 booster vaccination program will be conducted for aged care facilities commencing 8 November 2021. Rosewood is seeking informed consent from residents/substitute decision makers (email sent 27 October 2021) for boosters to be administered to residents. Boosters are available for all who received their second dose at least six months ago. Rosewood is waiting to be advised about when an onsite clinic will be conducted to provide boosters to those residents and staff eligible/wanting the booster. It is expected this will occur soon. Boosters are NOT mandatory. Two doses of a COVID-19 vaccine is still considered to be “fully vaccinated”. However, a booster

vaccine helps to increase the effectiveness of the vaccine. The only vaccination currently approved as a booster is the Pfizer Comirnaty vaccine.

The WA Premier Mark McGowan has announced that anyone who has received their second dose of a COVID-19 vaccine over six months ago can walk-in to any state-run vaccination clinics to receive their booster vaccine without an appointment.

## ENDURING POWER OF GUARDIANSHIP

Many residents/families have nominated an EPA (Enduring Power of Attorney) for management of financial decisions. Less have nominated an EPG, an Enduring Power of Guardianship. An Enduring Guardian is considered to be an appropriate substitute decision maker for all clinical decisions, if an Advance Health Directive is not in place.

If you do not already have an Enduring Power of Guardianship and Enduring Power of Attorney in place, you can find information about how to put these in place, including forms to complete, through the Office of the Public Advocate WA [<https://www.publicadvocate.wa.gov.au/>].

Some EPG factsheets have been printed and placed at reception for your convenience.
